C. Smith confirmed that direction was to review all signage - not just small signs. He noted that there are a lot of inconsistencies and Council needs to address the whole signage issue.

Deputy Mayor Cassista posed a friendly amendment to remove the word "small" from the motion. The seconder agreed to the friendly amendment.

Councillor W. Bennett remarked that some people make a living from what they do and post such advertisements on small signs. Perhaps it might be an idea to keep in mind to set a limit on the amount of time of such a posting could be up.

11. NEW BUSINESS

a. Award of Tender 17-27

Supply of (1) Propane Emergency Generator

Moved by: Councillor T. Rampersaud

*That the contract for the Supply of One Propane Emergency Generator for the Riverview Fire & Rescue Station, Tender **No. 17-27**, be awarded to Source Atlantic in the amount of \$55,303.50 (HST included), this being on the recommendation of the Fire Chief and the CAO and that the Mayor and Town Clerk be authorized to execute all related documentation.*

Councillor Thorne indicated that he was glad to see the tender come in under budget.

Chief Pleau confirmed that it is estimated that the cost to repair the hole in the wall once the generator is installed would hopefully be under \$10,000 and that this work would be carried out "in house".

b. Award of Tender 17-71B

The Supply & Installation of Dump/Spreader Box and Plow Equipment

*That the contract for the Supply and Installation of Dump/Spreader Box and Plow Equipment, Contract **No. 17-71B**, be awarded to Phil LaRochelle Equipment in the amount of \$92,990.06 (plus HST), this being on the recommendation of the Director of Engineering & Works and Engineering and the CAO and that the Mayor and Town Clerk be authorized to execute all related documentation.*

c. Award of Tender 17-75 -

New Hydroseeder

That the contract for the Supply of one new Hydroseeder, Tender #17-75, be awarded to Park Lane Marketing Ltd. in the amount of \$18,591.70 (plus HST), this being on the recommendation of the Director of Engineering & Works and that the Mayor and Town Clerk be authorized to execute all related documentation.

M. Ouellet confirmed that there are more companies that carry this product but only one company had submitted a bid on this tender. He pointed out that this item is over the budgeted amount but still recommends to proceed with its purchase.

Councillor Thorne inquired as to why the budget was only \$10,000?

M. Ouellet indicated that the budget estimate for this item was not in line with the actual cost of the equipment. He confirmed that there are no shipping fees for this item as it would be included in the tender price.

M. Ouellet confirmed with Deputy Mayor Cassista that so far this year the department is \$750,000 under budget.

Councillor LeBlanc remarked that these savings were to be applied to the work to be undertaken at the Byron Dobson Arena work.

C. Smith confirmed that was the initial option. However, there is also the option of dipping into capital reserves if required, once all the project projections are in.

M. Ouellet noted that the tender amount for the dump/spreader box was \$20,000 under budget. This savings was not was not included in the \$750,000.

Deputy Mayor Cassista noted that she is satisfied with the response from the Director. She also indicated that these items were discussed at budget deliberations and justified at that time.

M. Ouellet confirmed with Councillor Thorne that the hydroseeder is more efficient.

M. Ouellet confirmed with Councillor Bennett that it would be used for lawn damage and local improvement. The equipment would be available to the other departments.

d. Award of Tender 17-76 -

2017 Model 15" Diameter Drum Style Wood Chipper

Mayor Seamans appointed Mr. Arthur Allan for a two-year term commencing July 19, 2017 and ending July 19, 2019 to the Greater Moncton International Airport Authority Board.

Mayor Seamans noted the Airport Authority has changed the way new applicants are brought forward to the Board. The Airport Authority screens the applicants and then forwards a name to the Mayor for consideration and formal appointment.

g. Resolution - Apply for Funding for Consulting Fees for Asset Management Plan

Be it therefore resolved that the Town of Riverview commits to conducting the following activities in its proposed project submitted to the Federation of Canadian Municipalities' Municipal Asset Management Program to advance our asset management program.

- *State of the Infrastructure Reporting Methodology*
- *Development of Level of Service Framework and Methodology*
- *Development of Asset Management and Financial Strategy*

BE IT FURTHER RESOLVED that the Town of Riverview commits \$ 10,371 from its budget toward the costs of this initiative.

Councillor Thorne noted that he had been advised that Eco 360 will clean up unauthorized dump sites.

Councillor Thorne also stated that he recently attended the Federation of Canadian Municipalities from May 31st to June 4th in Ottawa. He commented that the conference was very informative.
