6. CORRESPONDENCE

 a. S. Anderson - Proposed Rezoning & Resolution to Set down dates for Public Presentation & Public Hearing

Property located at 1174 Coverdale Road

Moved by: Councillor J. Coughlan Seconded by: Councillor J. Thorne

WHEREAS Riverview Town Council intends to amend its Municipal Development Plan By-law 300-32, Zoning By-law 300-6, by considering the following amendments:

- 1) Municipal Development Plan By-law 300-32-2 to amend 1174 Coverdale Road from CU (Community Use) to C (Commercial).
- 2) Zoning By-law 300-6-14 to amend 1174 Coverdale Road from PRI (Parks, Recreation, & Institutional) to NC (Neighbourhood Commercial) with the addition of entertainment uses permitted as a secondary use within a maximum of 40% of the gross floor area.

BE IT RESOLVED THAT:

- a) That a public presentation for the plan amendment be scheduled for February 26, 2018 at 6:30 p.m. in the Council Chambers at Riverview Town Hall;
- b) That a public hearing be set for April 9, 2018 at 6:30 p.m.in the Council Chambers at Riverview Town Hall;
- c) That By-laws 300-32-2 and 300-6-14 be referred to the Planning Advisory Committee for its written views;

AND FURTHER, the rezoning, if approved, should be subject to a conditional zoning agreement, including but not limited to:

1. That full floor plans for both floors be submitted as part of the application for a building and development permit; and

- 2. That entertainment uses be permitted in only 40% of the gross floor area of the building, and the area should be indicated on the above noted floor plans.
- S. Anderson remarked that the Municipal Development Plan By-law 300-32-2 proposes to re-designate 1174 Coverdale Road from CU (Community Use) to C (Commercial). Further that the proposed amendment would allow for the property to be rezoned from PRI (Parks, Recreation, & Institutional) to NC (Neighbourhood Commercial) with the addition of entertainment uses permitted as a secondary use within a maximum of 40% of the gross floor area.

She noted that the purpose of the rezoning is to accommodate a residential home with rentable space in the basement for small gatherings, meetings, social clubs and senior's groups, as well as small scale retail associated with the gathering space in the basement.

- S. Anderson advised that the new landowner wants to create a living space on the main floor and use the basement for entertainment. The proposed new uses are a residential home; small scale retail; and entertainment. She pointed out that the idea was to limit the extent of entertainment to a secondary use (within a maximum of 40% of gross floor space).
- S. Anderson indicated that the recommendations are to move forward in the process with the Municipal Development Plan by-law amendment 300-32-2; and the Zoning by-law amendment 3 00-6-14 and further that it be referred to PAC for written views;
- S. Anderson confirmed with Councillor Thorne that notice of the proposed rezoning would be posted in the newspaper. The Town is also required to provide thirty days from the date of the advertisement to receive written objections.
- S. Anderson confirmed with Councillor Thorne that the grave yard has been subdivided out and will be owned and maintained by the church.

- S. Anderson confirmed with Councillor Rampersaud that in the past there have been inquiries about the property but no one has actually come forward and submitted a rezoning application.
- S. Anderson indicated that the proposed resolution will set down the date for public presentation (February 26th) and public hearing (April 9th) and also officially request the written views of the Planning Advisory Committee.

b. Imagination Library - Long Term Commitment

That Riverview Town Council approve a long term financial commitment for a three year period beginning in 2019 in the amount of \$500 annually to the Moncton Regional Learning Council in support of the Imagination Library which will allow Riverview to become a catchment area for the program.

Mayor Seamans confirmed that the Town had provided financial support of \$500 in 2017 and 2018. The motion is to provide a further three year commitment beginning in 2019 for \$500.

Councillor Rampersaud noted that the original ask was \$1,000 per year for three years but the motion was for \$500. She reported that during a previous presentation by D. Taylor, she had indicated that the program could get moving with a long term commitment of \$500 per year for three years.

C. Smith noted that the question arose as to when the commitment had begun since technically the Town has provided financial support both in 2017 and 2018. However, the motion outlines the level and duration of the commitment.

11. **NEW BUSINESS**

Councillor Rampersaud wanted to express her appreciate for the many hours of work put in by the departments in order to make the Winter Carnival a huge success! She also reported on the many positive comments she had received regarding the Town's snow clearing operations.

Councillor Cassista wanted to express her appreciation to Mayor Seamans for voicing her opinion on the topic of amalgamation. She inquired whether this would be an item for further discussion by Council.

Mayor Seamans noted that the question was posed by a reporter at the end of a CBC interview which prompted comments from the other two Mayors resulting in comments appearing on social media. Mayor Seamans noted that she took the opportunity to ask the opinion of a large group of seniors (320) who recently attended the Mayor's Winter Carnival luncheon and only 3 people were in favour of amalgamation. Mayor Seamans indicated that unless the residents bring it forward then the issue would not be pursued. Mayor Seamans suggested that she has not seen the benefits of amalgamation; but if that changed then the issue could be revisited.
