Chief Pleau confirmed with Councillor Thorne that this tender represents the last phase of repairs to the roof. He pointed out that the repairs to the trusses were completed last year.

Deputy Mayor Bennett recalled that there was a cracked wall in the bay area that needed attention. Chief Pleau remarked that a structural engineer had reviewed and determined that the Town could wait to repair.

Councillor Cassista recalled that Council had budgeted to have the wall taken care of and at that time was led to believe it was a serious matter.

Chief Pleau confirmed that last year the critical work that needed to be carried out was the replacement of the trusses. The 2018 budget identified the replacement of the roof shingles. He remarked that the engineer recommended to hold off on the repair to the wall.

C. Smith commented that a constructional engineer identified that the immediate priority was the truss; the wall was not identified as an immediate issue.

Chief Pleau assured Councillor Cassista that the building is and will continue to be monitored every day.

C. Smith confirmed with Councillor Cassista that the agent will get a percentage of the sale once sold which was outlined in their RFP submission. Their percentage would be based on different scales for different sale prices and was consistent with other submissions from other proponents.

C. Smith pointed out that as their commission could have potentially exceeded the procurement threshold the Town was required to proceed with a Request for Proposal.

12. COUNCIL STATEMENTS/INQUIRIES

Councillor Hansen remarked that she had received concerns about portable signage along Coverdale Road.

S. Thomson noted that a review of the sign by-law began last year and the Urban Planning Department was assisting in this endeavour. The Town had conducted a survey in order to engage the public and understand what type of signage was considered acceptable. The results were reviewed in November and a review began. However, the staff member assigned to this file took of leave of absence, and the Town is now following up on this work.

C. Smith remarked that he will follow up and work with Urban Planning to determine a timeline for this to be brought back to Council for consideration.

Mayor Seamans indicated that it seems that the signs along the Riverfront are an area of concern.

Councillor Hansen remarked that it was her understanding that there was supposed to be no signage on the Riverfront with the exception of community group signs which were temporary in nature.

C. Smith stated that at some point the Town will have to address the question of signage along the Riverfront either through the creation of a formal policy (who, how long signs remain); or through a by-law. He understood that the intent was to support the minor sports groups which would erect signs for a short period. Either way Council would have to provide direction to staff.

Deputy Mayor Rampersaud wanted to pass along thanks to A. Crummey and M. Cross with the pet information. Also she indicated that she is very appreciative of the deer announcement.

Councillor Thorne offered his thanks to Gordon McNutt, the new commissionaire, for doing a great job. He sees him out every day and his work has not gone unnoticed.
