#### 8. RECOMMENDATIONS FROM COMMITTEE OF THE WHOLE

a. Approval of Fire Department Strategic Plan 2018 - 2023

Since it is a public document, the public can assess it through that means. He remarked that it was not his intention to make a special post on the Town's web site.

Councillor Thorne wanted to ensure that the public is looking at the up to date version of the plan. He wanted to prevent confusion by the public if they were able to access older versions.

C. Smith stated that he appreciates this comment and will take steps to ensure that this does not happen.

Deputy Mayor Rampersaud indicated that she was very pleased with the process and the end result as it outlines Council's priorities.

### 11. **NEW BUSINESS**

# a. Award of Tender 18-03 - Lane Markings - Various Streets

Moved by: Councillor J. Coughlan Seconded by: Councillor C. Cassista

That the tender for Traffic Lane Markings - Various Street, Tender 18-03, be awarded to Stripe Works Ltd. in the amount of \$32,156.00 plus HST and that the Mayor and Town Clerk be authorized to sign all related documentation.

M. Ouellet confirmed with Councillor Cassista that while the tender closed on March 6, 2018 the Town was waiting on a safety certification document which was a condition of the award of the tender. That was the reason for the delay in the award of the tender.

Mayor Seamans noted that currently the lines are not visible in some places making it dangerous.

Deputy Clerk confirmed with Mayor Seamans that once the motion is approved the contract is ready for signature and once the contract has been executed by both parties the work can proceed.

#### b. Summer Hours

### c. Contract 18-70 - Revised Contract Price

That the contract price for Tender 18-70 previously awarded to Dexter Construction Company Ltd. at the Special Council Meeting of May 7, 2018 be amended to \$1,698,163.90 plus HST due to final adjustments.

It was noted that the tender price awarded at the Special Council Meeting on May 7, 2018 was \$1,694,384.90 plus HST.

M. Ouellet remarked that as Council was aware the tender price was considerably higher than budgeted. This resulted in the Town approaching the contractor to see how the contract could be reduced. Over \$200,000 in savings was found. However, one item had to be amended due to minimum purchasing quantity of this item and the total anticipated savings of \$39,000 only came in at \$35,000 which resulted in the difference in the revised price.
