## **Mayor's Christmas Tree Lighting**

The annual Mayor's Lighting was held at Town Hall on November 23, 2016. It was hoped to move the event to the Chocolate River Station, however, work being completed on their parking lot prevented us from moving the event for 2016. As has been the case every year, attendance was up in 2016, so there is a need for a new venue to accommodate the numbers. We are very much looking forward to hosting the event in the downtown area in 2017, partnering with the success of the "Light Up Riverview" campaign.

### **Mayor's Luncheon**

the Future	Planning is ongoing for Mayor's Luncheon on February 8 <sup>th</sup> at the Coverdale Centre as well as other community wide special events with Canada150 as the theme/enhancement.
Smart and Sustainable Growth	Staff has been working in cooperation with the Communications Department and Branch Design on an interpretive panel to be installed in the spring near the "Third Wave" Sculpture created by artist Julie Glaspy, as part of the Sculpture Saint John Program.
Fiscal	Program Registration
Responsibility and Service	Winter program registration was held for age 60+ on December 8, 2016. In the first hour of registration, we had 23 in person registrations and 29 online registrations.
Excellence	On December 13, 2016, winter registration began for the remaining programs (adult, children and swimming lessons). Within the first 23 minutes of registration, 129 online registrations and 19 in person registrations were processed. Two hours into registration, there were 180 online registrations and 25 in- person registrations.

## Section 3: Other Notable Development & Highlights for Council's Attention

#### **Coverdale Centre**

The commercial dishwasher, situated in the kitchen, is scheduled for immediate replacement due to operating issues that have been reoccurring during high traffic functions. The current dishwasher was purchased during the original renovations completed in 1990-91.

All floor surfaces in the building have been re-waxed to protect them, as part of the life cycle maintenance for this building. This includes the main hall, hallways, kitchen, and bathrooms.

The department has been working with NB Power to have one of the parking lot lights moved, recently placed to enhance user safety, as a result of a complaint regarding light pollution at their residence. Power outages across the province had tied up their resources prior to Christmas and they have this item on their list of things to do.

#### **Pat Crossman Memorial Aquatic Centre**

Twelve staff from the Lifeguard Apprentice Program were successfully certified on Dec 18<sup>th</sup>, providing PCMAC with a fully certified staff group.

Lifesaving Society of New Brunswick Annual Grand Meeting (March)

Canadian Red Cross Atlantic-Region instructor trainer and recertification workshops to assist at a higher level with provincial staffing shortages (March and June).

#### Service Enhancements

PCMAC began selling goggles and swim caps at an affordable cost. It has greatly benefited those who forget their swim items.

The review of an addition of a weekend lane swim time is underway. This will be a much needed swim for adults and 60+ on weekends, as there are presently only lane swimming through the weekdays.

Swimming lesson classes with low registration were combined where possible, to avoid cancellations this session.

A streamlined rental process now allows residents to access information and book the facility at the pool location through aquatic staff. Previously this was done through the Parks & Recreation Administration Office.

The booking of private lessons has been streamlined so users are now able to book online alongside current programs.

The addition of a punch-pass for non-resident 60+ has been implemented to reduce patrons from having to pay each visit.
