Section 2: Status of Department's Operational Priorities for 2023

| Administration | The draft of the 2024-2028 RFR Strategic Plan is complete. The department will be working with Communications in January to prepare a final document for presentation. A volunteer firefighter recruitment was successfully conducted over November and December, with training of eleven new firefighters to commence in January. |
| Operations | The annual call volume for Riverview Fire and Rescue increased 37% in comparison to 2022. This was driven by both a higher number of medical calls, and a higher number of residential and commercial fire alarms. Medical calls are expected to stabilize, but in other categories a gradual continued increase is anticipated. Two volunteer firefighters completed Level One Training and have commenced their probationary period. |
| Training | A total of 287 total training hours were completed in November, and a total of 106.75 in December. Topics included: Highrise fire operations; Case study related to propane leak response; Medical Director testing; Fire Dynamics presentation. An ICS 200 course was held at Riverview Fire and Rescue, with one TOR staff member receiving certification. Two career firefighters were certified as confined space entry and rescue instructors. Ten volunteer firefighters achieved ICS 100 certifications. |

Fire Inspections
