The residents of 204, 208 Coverdale Road, "Bella Casa Apartments" and 230 Coverdale Road, "The Tides" Apartment, wish to offer the council the enclosed proposal - "That Riverview Town Council request a Codiac Transit bus stop be located near the currently approved crosswalk location at the entrance to the Golf Club Road."

Residents of these three apartment buildings have been made aware of the tendered plans for the crosswalk and have agreed that a bus stop adjacent to this crosswalk would be most desirable.

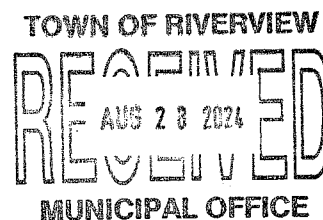
Ms. Cecile Cassista has been contacted re our concerns and has offered to bring this proposal before Council at the next meeting in early September.

We, the undersigned, wish to propose that the bus stop currently located near the intersection of Coverdale Road and Pine Glen Road be relocated to the vicinity of the Moncton Golf Club Road intersection with Coverdale Road.

As the proposed crosswalk has been tendered to be located near this intersection, bus stops for both directions would be ideal. Benches and shelters would be valuable assets for times of inclement weather, particularly in winter.

There are currently four apartment buildings in close proximity, with an estimated population of 200 potential customers for bus services.

This location for Codiac Transit to provide for these citizens would greatly enhance Riverview's services for Seniors.
