# Presentation by Shane Thomson - Preview of Town of Riverview's updated web site

S. Thomson reported that the marketing communication, which was approved by Council in 2016, recommended the redevelopment of the Town's web site. He wanted to provide Council with a sneak preview before it is launched to the general public.

He highlighted a few elements about the site which is set up for smart phones and tablets, web content accessibility, and the site is 100% powered by renewable energy. A fully-functional Emergency Measures Organization warning system built into every page of the site, which can be managed from any mobile device with a 3G connection. On line forms now available, site will show facility cancellation in real time, and Tidal Bore information in real time. The site will also integrate with escribe agenda.

- S. Thomson confirmed with Councillor Cassista that the web site will be up and running at the Visitor Information Centre which will contain information about the Tidal Bore.
- S. Thomson confirmed with Councillor Coughlan that users can bookmark the Town's website into their phone as a short cut. Instead of the Town developing an app which is costly.

- S. Thomson confirmed with Deputy Mayor Bennett that the web site designer, as well as the Committee, went to great lengths to solve all the "pain points" to allow for a more user friendly and accessible system. Hopefully, these improvements will address his concern regarding difficulty in navigating the by-law section.
- S. Thompson extended his appreciation to the Committee members who reviewed the site's new content to make it user friendly and to easily find information. The Committee consisted of Annette Crummey, Meghan Cross and Dave Shea.

#### 12. NEW BUSINESS

a. 2017 - Transfer from General Operating Fund to General Capital Fund

# c. 2017 - Transfer from General Capital Reserves to General Capital Fund

# d. 2017 - Transfer from Utility Capital Reserve to Utility Capital Fund

R. Higson reported that the Town had just received confirmation that the amount of the Local Service District funds paid by the Province to the Town would be decreased by \$37,000 based on a formula used by the Province. The Town had projected the amount of \$410,175 and staff had to decrease the revenue side by \$37,000 in the Town's budget to reflect this change and also reduced Capital from Operating by the same amount. He confirmed that the change has no impact to any other line items.

R. Higson confirmed with Councillor Cassista that based on his understanding from the Province the formula takes into consideration (among other components) debt borrowing (a large debenture was paid off in 2016); another factor taken into consideration is the tax base for the LSD which had also decreased; therefore, the Town would get less money to service the smaller tax base.

## I. I.A.F.F. Local 2549 - Ratification of contract

C. Smith indicated that the new structure will be a Provincial asset and it will be their responsibility to carry out maintenance albeit those repairs / maintenance may not be at a pace Council is necessarily satisfied with.

# n. Planning & Building Inspection Agreement

Town Council direct Town staff to notify the City of Moncton that the Town of Riverview is giving the City notice, per terms of the agreement, that it is opting out of the current Building Inspection and Municipal Planning Services Agreement. Furthermore, Council directs staff to begin discussions with the Regional Service Commission to enter into a direct service level agreement with the Regional Service Commission to deliver Planning and Inspection Services for the Town of Riverview.
