Two bids were received for Tender 17-41A Byron Dobson Arena-Phase 1 Facility Upgrade & Improvement – Lower Rink Ventilation Modifications & Dehumidification.

### (1) Brunswick Sheet Metal

One Hundred and Sixty-One Thousand, Five Hundred Seventy-Five Dollars (\$161,575.00) applicable taxes included.

### (2) East Coast Sheet Metal

One Hundred and Fifty Thousand, Two Hundred Fifty-Three Dollars and Twenty-Five Cents (\$150,253.25) applicable taxes included.

The budget for this project before taxes is One Hundred and Thirty-Two Thousand, Seven Hundred Dollars (\$132,700). Based on the construction cost of \$136,261 (incl. 4.29% HST) this portion of the project will be approximately \$3,561 over budget.

I recommend that the Tender be awarded to **East Coast Sheet Metal Ltd.** in the amount of One Hundred and Fifty Thousand, Two Hundred Fifty-Three Dollars and Twenty-Five Cents (\$150,253.25) applicable taxes included.

#### Introduction

The tenders have closed for the work for Lower Rink Ventilation Modifications & Dehumidification (Package M1) at Byron Dobson Arena, Riverview, New Brunswick.

The following is a summary of the tenders and our recommendation.

### 1. Scope of the Work

The work in the tender documents generally includes:

- Modifications to the Lower Rink dehumidification system:
  - Removal and disposal of the two (2) existing dehumidifiers.
  - Supply and install two (2) new dehumidifiers and associated services.
  - Provide new electrical and controls.
- 2. Installation of the Lower Rink CO detection and purge system will include:
  - Supply and install two (2) new sidewall louvers complete with intake plenums and dampers.
  - Supply and install one (1) new sidewall exhaust fan complete with intake plenums and dampers.
  - Supply and install new Carbon Monoxide detectors and integrate into

the existing Delta DDC. Provide wire guards for protection.

- 3. Modifications to the Upper Rink CO detection and purge system will include:
  - Removal of the two (2) existing CO detectors.
  - Supply and install two (2) new Carbon Monoxide detectors integrated to the existing Delta DDC.
    Provide wire guards for protection.
  - Supply and install of a new sidewall exhaust fan and remove the existing roof-top exhaust fans.

### The budget for the work is:

#### 2. Tender Process

MCW Maricor prepared the technical drawings and specifications. MCW provided the contract requirements and general conditions ('front-end') specifications based on the Town of Riverview front end tender documents. The information was advertise and made available publically. There was a non-mandatory bidders meeting held at the site. Two Addenda were issued.

The Tenders were received at the Town Hall of Town of Riverview on June 28, 2017 and opened in public immediately after the close.

The Bidders were as follows:

- 1. East Coast Sheet Metal Ltd.
- 2. Brunswick Sheet Metal Ltd.

### 3. Tender Results

The summary of Tender responses from the Bidders and the Lump Sum bids were submitted as follows:

East Coast Sheet Metal Ltd.

\$130,655.00 + HST

2. Brunswick Sheet Metal Ltd.

\$140,500.00 + HST
