4. AWARD OF TENDER 17-41B - BYRON DOBSON ARENA - PHASE 1

FACILITY UPGRADE AND IMPROVEMENT - LOWER RINK VENTILATION MODIFICATION & DEHUMIDIFICATION

That the contract, Byron Dobson Arena - Phase 1 - Facility Upgrade & Improvement - Lower Rink Ventilation Modifications & Dehumidification, Tender #17-41B be awarded to East Coast Metal Ltd. in the amount of \$150,253.25 (applicable taxes included), this being on the recommendation of the Director of Parks, Recreation and Community Relations and further that the Mayor and Town Clerk be authorized to execute all related documentation.

C. Smith remarked a full report was submitted to Council on a number of issues addressed through the facilities conditions assessment. Staff came back and recommended that Council focus on the Byron Dobson arena projects for this year. Council had authorized staff to proceed to spend up to \$750,000 on all the

arena projects using the tender savings and other savings as a method to pay and if further monies were required, funds in the capital reserves could be considered.

The four tenders for the Byron Dobson arena were packaged together but when you factor in the four tenders plus work that MCW has done to manage the project for the Town and based on the tender results overall, we are looking at \$50,000 under what was anticipated from the total budget Council authorized to proceed.

C. Smith confirmed with Councillor Cassista that although the tender opened this morning was tight, the process was followed and executed. A report from MCW was attached to the Council package and their recommendation was done based on the tender opening and in ensuring it complied with the tender.

C. Smith confirmed with Councillor Thorne that some work has started with regard to the other tenders, such as the work on the facility electrical panel.
